WHEREAS, after multiple mediation sessions before an experienced mediator, the parties reached a settlement that, subject to final approval, resolves Plaintiff's claims and those of the class.

6 WHEREAS, on February 18, 2022, the parties filed a Motion for Preliminary
7 Approval of Class Action Settlement (ECF No. 64).

WHEREAS, the Motion for Preliminary Approval of Class Action Settlement was granted on April 14, 2022 (ECF No. 68).

WHEREAS, the parties have worked diligently to proceed under the timeline
in the Court's order and to meet the deadlines set forth.

WHEREAS, the parties recently discovered a data issue where a particular
segment of the "known" class was excluded from receiving notice. The parties have
identified the issue and a remedy and intend to issue an identical notice to that
approved by the Court to that excluded group (the "Supplemental Notice") within 14
days of the entry of the Order on this Stipulation.

WHEREAS, those known class members who were inadvertently excluded
from the initial notice and will receive the Supplemental Notice are entitled to ninety
(90) days to exercise their rights to opt out of or object to the Settlement. That 90day window will exceed current deadlines approved by this Court. As a result, the
Parties request that those certain deadlines be extended as provided in the chart
below.

WHEREAS, the parties believe that no known or unknown class member will
be prejudiced by the requested extension of the applicable deadlines and the
extension will ensure that all known class members receive the Court-approved
notice.
